Mr. Mohandas Pai is an Indian businessman, who as the CFO of Infosys, played a strategic role in transforming the company into one of the world's most respected and widely known software services firms and helped enable the company to receive the first ever listing of an India-registered company on NASDAQ. He is a Padma Shri Awardee by the Govt. of India, and one of the most dynamic philanthropist and influential mentor & investor in the country.

Succeeding his role at Infosys, Mr. Pai had taken up other prominent roles in parallel, a few of which are below:
